

Pharmabridge - offer by Professor Gary Smith

Offer for education and training on immunization and various pharmacotherapeutic and drug information topics for pharmacists and other health care professionals in developing countries

Gary H. Smith, PharmD, FASHP, FCCP, Professor of Pharmacy Practice at Midwestern College of Pharmacy Glendale, Arizona but acting as a private consultant, offers to Pharmabridge to teach the following topics/courses in developing countries:

- Immunization for Health Care professionals. Prof Smith is APhA certified immunization trainer and has done five training sessions in Arizona during 2011 as well as a course in Nigeria
- HIV/AIDS: Epidemiology, testing, pathophysiology, pharmacotherapy, opportunistic infections, mother-to-child transmission and treatment of HIV during pregnancy, drug-drug interactions, adverse effects, adherence counseling and monitoring, management of co-infections, and overall patient management. Cases to be included. (2-4 days)
- Short course in pathophysiology and pharmacotherapy of infectious diseases including: Community and hospital acquired pneumonia, upper respiratory tract infections, infective endocarditis, tuberculosis, skin and skin structure infections, viral infections (influenzae and hepatitis), Fungal infections, sexually transmitted diseases, meningitis, urinary tract infections, GI infections and eye infections. Cases will be included (2-4 days)
- Drug information course including: systematic approach to answering drug information questions; primary, secondary and tertiary references sources; literature evaluation; formulary development and management; medication use evaluation; and new drug evaluation. (2-3 days)
- General patient management: The pharmaceutical care plan, history taking, patient counseling, SOAP notes, monitoring, etc.) (1 day)
- Case Based Infectious Disease Course: Consists of 10 cases with in depth discussion about the disease including key decision points and how decisions are made with respect to therapy. Key and sentinel articles from the primary literature will be provided for each disease discussed. (3-4 days)

These topics/courses could include 30-50 people in a lecture format. However, case discussions are best conducted with 25 or less participants. Each of the courses will involve some case discussions.

Consultations on various aspects of pharmacy practice can also be provided such as setting up a clinical pharmacy program in a hospital or ambulatory clinic; developing and managing a drug information center; developing and managing a drug formulary; other pharmacy practice needs can be negotiated on an individual and as needed basis.

Professor Smith is prepared to tailor courses and consultations to the local needs including desired duration between 5-15 days. Longer time periods can be arranged or more than one session with a minimum of one month between sessions.

Expectations of hosting organization:

- Promotion and provision of sufficient participants for course(s)
- Photocopying of any handout material
- Audiovisual equipment for presentation such as power point equipped computer with pc operating system and an LCD projector
- Accommodation for two at a business class hotel (4 star minimum) or adequate university housing and food
- Airfare (full fare economy) between USA base and destination
- Local transportation provided
- Professor Smith does not expect to be paid for his time
