

## FIP Individual Membership Terms and Conditions

### General

1. Individual membership of the International Pharmaceutical Federation (FIP) is for individual pharmacists, pharmaceutical scientists, pharmacy students and anyone with an interest in pharmacy and/or pharmaceutical sciences.
2. Our membership cycle runs from 1 January until 31 December.
3. For new members who register with FIP during the annual FIP congress, or during September, October, November or December, membership will officially start on 1 January of the consecutive year, although it will be activated immediately.
4. Members are entitled to a membership certificate (printable online). A full list of member benefits can be found [here](#).
5. FIP works according to EU General Data Protection Regulation. Our privacy statement can be found [here](#). Members using the FIP Network (our online directory that facilitates connection with other FIP members) agree not to use any of the network data for commercial purposes. Individuals violating this rule will have their membership cancelled.
6. FIP members may claim a reduced congress registration fee if they:
  - have been a member for 2021 (fee needs to be paid) and have fully paid up their membership for 2022, OR
  - have been a member for 2022 (fee needs to be paid) and have fully paid up their membership for 2023 before 31 May 2023, OR
  - become a member before 31 May 2023 and pay for two years in advance (2023 and 2024).

### Fees, payment and cancellation

7. Once your first membership fee is settled, we will activate your access to all member services.
8. When you become a member, you agree to pay the annual fee by 31 January each year. You can make your payment online through the FIP website or via bank transfer with the following instruction:

9. We will send you your invoice through email for payment.
10. You will not be entitled to a refund of any fees already paid.
11. Providing false information in order to receive a lower fee will result in cancellation of membership.
12. If you no longer wish to be a member you can decide to leave at any time by writing to [membership@fip.org](mailto:membership@fip.org) with at least one month's notice before your next payment is due. There are no automatic cancellations. If we receive no cancellation notice, fees in your account will accumulate until payment is received.
13. FIP has the right to defer a decision to cancel your membership. Your membership may be suspended and you will not be entitled to access any benefits.
14. If you or FIP cancels this agreement under any circumstance, FIP is still entitled to collect any outstanding membership fees.
