The Taskforce is hosting a side meeting at the **Second Global Forum on Human Resources for Health** taking place in Bangkok, Thailand, on 25-29th January 2011. In addition, a case story we submitted entitled, '**Quality Assurance in Education: A cornerstone for strengthening the pharmacy workforce**' will be presented during the conference. As you may be aware, the FIP Pharmacy Education Taskforce was launched at the First Global Forum in Kampala, Uganda, in 2008. So we are very excited to be involved in the second forum and to be able to share all the work we've achieved since then! Based the continued interest raised during the global education consultations, the Taskforce is developing a fourth domain on the "**Pharmacy Support Workforce,**" which will focus on a needs-based approach to non-professional pharmacy cadres. More details to follow soon.

## **Conference Report**

*Prof Ian Bates, Director of the Taskforce, was invited to speak at the First Asia Pacific Pharmacy Education Workshop earlier this month. He has sent the information below about the conference.*

Management and Science University (MSU), Malaysia, United Nation University (UNU) and Universiti Sains Malaysia (USM) were joint hosts for the pharmacy education workshop in conjunction with the International Conference on Natural Products (ICNP) 2010. The main objectives of the workshop were to discuss issues around the standardization of pre-service and graduate pharmacy education in the Asia Pacific region and to initiate transnational approaches to pharmacy education in SE Asian region.

The workshop was held in Penang Island, Malaysia, on 11 and 12 December 2010. Speakers included Mr John Chang (FAPA), Prof Tan Sri Dato' Mohammed Salleh Mohammed Yasin (UNU and Malaysian Qualifications Agency), Prof Kenji Sugibayashi (Josai University, Japan), Prof Baidi Bahari (Assoc. Asain Schools Pharmacy), Prof Syed Mohammed Alijunid (UNU-IIGH) and myself.

The conference was concluded with a workshop session, whereby delegates reached consensus on a number of issues relating to QA of education, trans-border approaches and educational innovation. The workshop delegates voted to institute a regional taskforce in order to tackle these challenges by working across borders. It will be great to see what efforts come out of this initiative.

### **Jhpiego's New Training Skills eLearning Package**

The group has revised their ModCAL® (Modified Computer-Assisted Learning) for Training Skills, a computer-based knowledge update, as well as the Training Skills for Health Care Providers reference manual and related learning materials. According to Jhpiego, the new Training Skills course uses a combination of self-paced learning, delivered via ModCAL® for Training Skills, and individual coaching by a master trainer. ### **Sub-Saharan African Medical Schools Study**

The report **“The Sub-Saharan African Medical School Study: Data, Observation, and Opportunity”** has recently been released. The report outlines the site visit findings gathered from visits to ten medical schools and a survey distributed to 146 medical schools in the region. The report discusses some challenges including the mismatch between the number of medical students trained and the number of physicians the government can employ, the lack of coordination among ministries of health and ministries of education, the severe shortage of medical school faculty, the inadequate infrastructure, and the variability in secondary school education quality. The report also outlines the different levels of

innovations observed in the medical schools. Many of the medical schools emphasized “community oriented,” “relevant,” or “nationally focused” medical education to meet local needs. The Study reveals that medical schools in Africa have developed partnerships with medical schools in other countries to support teaching, service and research activities.
